Modern Slavery and Human Trafficking Statement

LAF Holdings Ltd (LAFH) will endeavour to make its business operations free from modern slavery or human trafficking, in line with Section 54 of the Modern Slavery Act 2015. This statement sets out policies employed and actions taken by LAFH during the financial year 2025/26.

LAF Holdings Limited comprises a number of subsidiary companies which operate primarily within three main fields - food, agriculture and environmental services. A full list of these companies is shown in Appendix A.

The company recognises the potential exposure to modern day slavery or human trafficking for staff or agents engaged by LAFH and within its supply chain. Whilst the majority of our direct suppliers are based in Europe, we recognise that our extended supply chain may originate from around the world.


During LAFH financial year, the company has taken positive steps in this area:

- We carry out audits to check that all our employees are paid at least the National Minimum Wage and have the right to work in the UK.
- Prior to engagement we consider our agency labour providers against the Ethical Trading Initiative (ETI) base code ethical standards. We also complete occasional spot checks on our temporary labour agencies. We endeavour to follow up any non-conformances or concerns in a timely manner.
- Any concerns about slavery or human trafficking can be raised through our reporting process.

In addition to producing the annual statement, LAFH will endeavour to:

- Consider and address slavery and human trafficking within our supply chain by using the Ethical Trading Initiative (ETI) base code.
- Identify any areas of high risk in our supply chain.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our group slavery and human trafficking statement for the financial year.
